The initial focus of this program is on Basic Training for Air Traffic Safety Electronics Personnel (ATSEP).

The IFATSEA Verified Training Program for ATSEP is a program aimed at verifying the Basic Training courses for ATSEP, who play a critical role in ensuring the safe and efficient operation of air traffic control systems. The program aims to ensure that ATSEP have received the necessary Basic training objectives to perform their duties and gain awareness to carry out their tasks.

The Verified Training Program ensures the global harmonization of Basic Training in support of the successful achievement of the Basic Training Objectives as listed in the International Civil Aviation Organization (ICAO) Manual on Air Traffic Safety Electronics Personal Competency-based Training and Assessment Doc 10057.

A delegation of IFATSEA visited the training academy of Entry Point North in Malmö, Sweden in February 2023.

Entry Point North (EPN) has been the first training organisation to have its ICAO ATSEP Basic Training modules audited through the new **IFATSEA Verified Training Program**.

EPN offers an ATSEP Basic Training **instructor-led classroom training** as well as **Online elearning modules**. Each course was reviewed under the IFATSEA Basic Verified Training Program. IFATSEA auditors are pleased to announced each course meets ICAO ATSEP Basic Training Objectives as listed in the ATSEP Competency-based Training and Assessment Doc 10057.
